

## TUITION INFORMATION

### SUMMER SESSION 1, 2022 TO END OF SCHOOL YEAR, 2023

- All tuition is based on monthly rates as stated above. Summer Sessions are billed at a monthly rate per session. If you need care for fewer than five days, the tuition above still applies.
- All families will sign a "financial agreement" form that delineates the hours each day that you require a placement for your child. This allows us to staff appropriately. If you occasionally need more hours than contracted, a call to the office by 4:00 on the preceding day is required to ensure we have sufficient staff.
- Tuition payments may be made in one of three ways:
  - A lump sum for ten months if you are starting in September. This payment plan will entitle you to a 5% discount if paid by cash/check or a 4% discount if paid by credit card by August 1, 2022. If you withdraw your child prior to the end of the 10 month period, your money will be refunded less the discount already applied.
  - A monthly plan is available with tuition due on or before the first of each month.
  - A Session I or Session II payment for Summer Sessions. Each session is equivalent to one month's tuition.
- Automatic payments may be deducted from your checking account or a credit card account on the 1<sup>st</sup> of the month (Friday if the 1<sup>st</sup> is a Saturday; Monday if a Sunday) if you choose to enroll in Tuition Express.
- If you choose to pay your child's tuition using a credit card, you will be assessed a 3% fee in addition to the monthly tuition. There is no fee charged if tuition is paid via check, cash, money order, or debit card/checking account.
- We accept ELRC subsidies. Students receiving this subsidy are governed by ELRC and by Shady Lane Financial Agreement provisions. Nonpayment of the co-pay within 5 days of its due date will be reported to ELRC.
- At the discretion of the executive director, you may temporarily withdraw your child due to a family emergency, and a *one-time* holding fee equaling 25% of your child's regular monthly tuition must be paid to hold the space for up to 3 months. The applicable form to make these arrangements may be obtained in the office.
